APPLICANTS MUST MEET THE FOLLOWING REQUIREMENTS:

1. Applicant must pick up the application in person and have a photo identification. A non-refundable **\$25.00** processing fee is due upon the receipt of the application. **Payment must be by money order or cashier's check, made payable to the: "Insulator's Joint Apprenticeship Program".**
2. Applicant must return the completed application to the office of the committee, postmarked on or before **May 2, 2025**.
3. Applicant must be a minimum of eighteen (18) years of age at the time of acceptance into program.
4. Applicant must be physically able to perform the work of the trade.
5. Applicant must be a high school graduate or have a G.E.D at the time of acceptance into program.
6. Applicant must have a dependable form of transportation.

7. Applicant must have resided within the geographical jurisdiction of the Heat and Frost Insulators and Allied Workers Local #2, for a minimum of one year immediately prior to the application date. (See below.)
8. Applicant will be required to take a written examination.
9. Applicant must pass a certified drug test, at the program's expense, before final acceptance into the program.

Applicants who qualify, based on the written examination, will be granted a personal interview.
